

License and registration for practicing dentistry

Systems to regulate the dental profession vary around the world. However, in **86 countries** out of the **88** (97%) it is obligatory to have a license/registration for dentists in their country/territory.

In contrast, **2** NDAs (3%) confirmed that it was not compulsory to get a license to practice in their **countries**.



Africa

License/registration is obligatory in all the 16 countries featured in the reports (100%).

Asia Pacific

License/registration is obligatory in all the 24 countries featured in the reports (100%).

Europe

License/registration is obligatory in 41 countries out of the 42 featured in the reports (98%).

Latin America

License/registration is obligatory in 3 countries out of the 4 featured in the reports (75%).

North America


License/registration is obligatory in both countries featured in the reports (100%).

Continuous Education

(the list only includes the NDAs / countries which submitted the NLO Reports)

Development through continuing education is an essential part of the dental profession. It is an important aspect of modern evidence-based dental practice. Furthermore, it is essential that dentists maintain an upto-date clinical and theoretical knowledge of the art and science of dentistry.

Thus, National Dental Associations were asked to provide information on Continuous Education in their countries. As per the replies from **88 countries**, Continuous Education is obligatory in **60 countries** (68%) and it is not obligatory in **28** (32%).



Africa

CE is obligatory in 10 countries out of the 16 featured in the reports (62%), in 6 countries it is not obligatory (38%).

Asia Pacific

CE is obligatory in 15 countries out of the 24 featured in the reports (62%), in 9 countries it is not obligatory (38%).

Europe

CE is obligatory in 32 countries out of the 42 featured in the reports (76%), in 10 countries it is not obligatory (24%).

Latin America

CE is obligatory in 1 country out of the 4 featured in the reports (25%), in 3 countries it is not obligatory (75%).

North America


CE is obligatory in both countries featured in the reports (100%).

Celebrating WOHD 2020

World Oral Health Day (WOHD) is celebrated globally every year on 20 March and is the largest global awareness campaign on oral health. FDI leads World Oral Health Day and develops the campaign strategy and messaging, which are then rolled out through National Dental Associations.

Out of **93 NDAs** that replied to the corresponding question in their NLO reports, **82 NDAs** (88%) planned to celebrate 2020 WOHD according to their NLO reports, **11 NDAs** (12%) did not preview any 2020 WOHD celebrations



Africa

WOHD celebrations were previewed by the NDAs in all the 15 countries featured in the reports (100%).

Asia Pacific

NDAs from 17 countries out of the 23 featured in the reports previewed WOHD celebrations (74%), NDAs from 6 countries did not preview any celebrations (26%)

Europe

NDAs from 43 countries out of the 48 featured in the reports (89%) previewed WOHD celebrations, NDAs from 5 countries did not preview any celebrations (11%)

Latin America

WOHD celebrations were previewed by the NDAs in all the 4 countries featured in the reports (100%).

North America

WOHD celebrations were previewed by the NDAs in both countries featured in the reports (100%).
